Statement of Faith/Lifestyle/Moral Integrity Standards

New Hope Christian Academy is a religious, nonprofit organization representing Jesus Christ throughout the local community. New Hope requires its employees, as well as volunteers who have unsupervised access to children, to be born-again Christians, living their lives as Christian role models (Romans 10:9-10; 1 Timothy 4:12; Luke 6:40) and model the same Christian values and lifestyle that it seeks to instill in its students.

Employees will maintain a lifestyle based on biblical standards of conduct. Employees will conduct themselves in a way that will not raise questions regarding their Christian testimonies. A Christian lifestyle should reflect the biblical perspective of integrity, appropriate personal and family relationships, business conduct, and moral behavior. An employee is expected to demonstrate a teachable spirit, an ability to share love to others, a willingness to live contently under authority, and a commitment to follow the Matthew 18 principle when an issue arises with fellow employees, families, or leadership.

Moral misconduct, which violates the bona fide occupational qualification for employees to be Christian role models, includes, but it not limited to, promiscuity and homosexual behavior or any violation of the unique roles of male and female (Romans 1:21-27; 1 Corinthians 6:9-20). New Hope believes that biblical marriage is limited to a covenant relationship between a man and a woman and there are unique roles of the male and female clearly defined in Scripture, and that Romans 1:24-32 condemns the homosexual lifestyle (Romans 12: 1-2; 1 Corinthians 6: 9-20; Ephesians 4: 1-11, 5: 3-5; 1 Thessalonians 4: 3-8; 1 Timothy 4: 12; 2 Timothy 2: 19-22; 1 Peter 1: 15-16, 2: 15-17; John 3: 1-3).
